

The State Use Law

63G-6a-804. *Purchase of prison industry goods.*

(1) (a) A procurement unit that is not a political subdivision shall purchase goods and services produced by the Utah Correctional Industries Division as provided in this section.

(b) A political subdivision of the state may, and is encouraged to, purchase goods and services under this section.

(c) A procurement unit is not required to use a standard procurement process to purchase goods or services under this section.

(2) On or before July 1 of each year, the director of the Utah Correctional Industries shall:

(a) publish and distribute to all procurement units and other interested public entities a catalog of goods and services provided by the Correctional Industries Division, including a description and price of each item offered for sale; and

(b) update and revise the catalog described in Subsection (2)(a) during the year as the director considers necessary.

(3) (a) A procurement unit that is not a political subdivision of the state may not purchase any goods or services provided by the Correctional Industries Division from any other source unless it has been determined in writing by the director of Correctional Industries and by the procurement officer or in the case of institutions of higher education, the institutional procurement officer, that purchase from the Correctional Industries Division is not feasible due to one of the following circumstances:

(i) the good or service offered by the division does not meet the reasonable requirements of the procurement unit;

(ii) the good or service cannot be supplied within a reasonable time by the division; or

(iii) the cost of the good or service, including basic price, transportation costs, and other expenses of acquisition, is not competitive with the cost of procuring the item from another source.

(b) In cases of disagreement under Subsection (3)(a):

(i) the decision may be appealed to a board consisting of:

(A) the director of the Department of Corrections;

(B) the director of Administrative Services; and

(C) a neutral third party agreed upon by the other two members of the board;

(ii) in the case of an institution of higher education of the state, the president of the institution, or the president's designee, shall make the final decision; or

(iii) in the case of any of the following entities, a person designated by the applicable rule-making authority shall make the final decision:

(A) a legislative procurement unit;

(B) a judicial procurement unit; or

(C) a public transit district.



Embroidery & Screen-Printing

UCI offers a state-of-the-art, digitized, embroidery service operation. The shop can embroider logos, message, images, team names, company names and more onto clothing and apparel or just about any accessory available.

Embroidery designs are stitched with an automated embroidery machine. These designs are “digitized” with embroidery software. They can have different types of “fills” which add texture and dimension to the embroidery design.

UCI Screen-Printing is able to create and design images that will be screen-printed on hats, bags, and clothing with up to a 6-color design that allows for customization of customer logos. Our shop can provide products and services not only to state agencies and schools, but also to private customers.

The Document Scanning, Data Entry & Micrographics shop receives documents from state, city and county offices and many federal agencies. The program participants are responsible for the management and physical care of the documents. The scanning and conversion of hard copy documents, maps, drawings, microfiche, & microfilm greatly minimizes the need for storage. Once scanned, the shop can couple the new digital documents with the necessary metadata and future searchability becomes easy and convenient.

UCI Commissary, based at the Utah State Prison in Draper, Utah, is a centralized canteen operation that provides services to the Draper Prison, Central Utah Correctional Facility, and the Sevier County Jail in Richfield. Commissary processes approximately 3,600 orders per week, utilizing a roller conveyor production line with item picking stations. Commissary offers products for sale to the offenders such as: packaged food items, writing materials, electronics, additional hygiene products, arts & craft supplies, and approved clothing items.

UCI Beverage Processing makes vitamin infused juice for all offenders in the Utah Department of Corrections facilities.

UCI mixes, pouches, and delivers all the juice in 8 oz. packages that include FDA approved nutritional guidelines and provide all required vitamins and nutrients.

The UCI Sewing Shop is located at Central Utah Correctional Facility. The shop produces all offender uniforms, jumpsuits, laundry bags, mattresses and pillows. The shop also sews and manufactures items for private businesses who partner with UCI via the Federal PIECP law. Notable PIECP items include binocular bags, trampoline park safety pads, inflatable movie screens and dog beds.
